Subject: Support for the Unanimously Adopted Bipartisan Amnesty Provisions for UFO/UAP Whistleblowers in the National Defense Authorization Act

Dear Senator,

As the Founder of the HSA Coalition, I write you to express my strong support for the unanimously adopted, bipartisan amnesty provisions for UFO/UAP (Unidentified Aerial Phenomena) whistleblowers included in the House and Senate National Defense Authorization Act.

Recent developments regarding UFO-related claims have shed light on the need for comprehensive measures to protect and encourage individuals with firsthand knowledge of these matters to come forward. The statements made by Senate Intelligence Committee Vice Chairman Marco Rubio and Representative Mike Gallagher, as reported in [The Hill](#), highlight the urgency and credibility of these claims.

The bipartisan provision adopted unanimously by the Senate Intelligence Committee, which would immediately halt funding for any secret government or contractor efforts to retrieve and reverse-engineer craft of "non-human" or "non-earth" origin, is a significant step toward addressing the alleged illegal activities. However, it is equally crucial to ensure the protection and safe disclosure of information by the whistleblowers involved.

Therefore, I ask you to consider adding the following provisions in the amnesty measures:

1. *Automatic Deeming of Security Clearances:* To prevent unnecessary delays, red tape, and bureaucratic hurdles, it is imperative to allow the security clearances held by any whistleblower to be automatically deemed as held by the office they seek to reveal their information. This provision will streamline the process and facilitate the timely dissemination of crucial information.

2. *U.S. Senate and U.S. House Select Committees on Intelligence as Safe Spaces:* Given the sensitive nature of the information being disclosed, it is vital to designate the U.S. Senate and U.S. House Select Committees on Intelligence as safe and secure spaces for UAP/UFO whistleblowers. These committees possess the necessary expertise and authority to handle such matters and ensure the protection of whistleblowers from any potential retaliation.

By implementing these provisions, we can establish an environment that encourages transparency, accountability, and the responsible handling of information related to UFO/UAP activities. The inclusion of legal protections for whistleblowers, along with the granting of legal immunity if the information is reported appropriately within a defined timeframe, will foster trust and cooperation among those who possess valuable insights into these matters.

The need for immediate action cannot be overstated, as recent reports have highlighted the existence of multiple craft of possible "non-human" origin in the possession of the U.S. government or private companies. The credibility and urgency attributed to these claims by the powerful investigative bodies overseeing intelligence agencies only reinforce the importance of addressing these issues promptly and effectively.

As the House and Senate National Defense Authorization Act approaches consideration on the House and Senate floor, please champion the cause of transparency and accountability by supporting the amnesty provisions for UFO/UAP whistleblowers. All of these provisions, especially amnesty, will not only serve the interest of national security but also uphold the principles of open government and responsible governance by contributing significantly to fostering a culture of disclosure, and, most importantly, ensure that the truth regarding UFO/UAP activities is brought to light.
